- The TOEH will only directly pay septic installers that are included on the Approved Vendor List
- Homeowners are not limited to hiring above listed vendors, but would be responsible for vendor payments and submitting proper documentation to the Town for a rebate.
- The Town of East Hampton cannot provide payment for sales tax. It is the responsibility of the homeowner to provide tax exemption forms or payments for sales tax.
- Septic incentive proceeds are taxable. Please consult a qualified tax professional to discuss implications.
- Vendors approved for direct payments by the Town of East Hampton may not be on the Suffolk County approved list. Homeowners who work with vendors not on the Suffolk County List may not be eligible for Suffolk County grant funding.
